All express mail must be left with <u>no acceptance signature required</u>. Checks returned for insufficient fees will render the entry invalid; acceptance of such an entry will only be made if the full fees, plus a \$25 administrative fee, are paid via certifed check or money order & received prior to the start of judging. Envelopes with more than 10 dogs' entries will be returned. Entry form changes, additions, corrections and cancellations MUST be received **in writing** prior to the November 22 closing date, be legible and include the AKC number, or no refund will be issued. No telephone changes accepted. Email changes are welcomed. Overpayments of less than \$10 per dog will not be refunded. Entry Forms will not be accepted that are missing information, unreadable, unsigned, sent without payment or with incorrect payment, or <u>sent without the full back of the entry form including the Agreement.</u> Entries received after the closing date, or after the stated numerical limits have been reached and wait list time has passed, will be destroyed once the entrant has been notified.

**WAIT LIST:** Entries received after the stated entry limits have been reached (but before the closing date/time) will be held on a wait list. If accepted entries are withdrawn before **Monday December 2 at 6pm**, entries on the wait list will be accepted subject to the per-ring limit. Entries withdrawn prior to the 12/2 6pm deadline *that are replaced by a waitlisted entry* will have entry fees reimbursed in full, as will any unaccepted wait list entries.

**REFUNDS:** No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil distubances, fire, an act of God, public emergency, or any other cause beyond the control of the organizing committee. Entry fees shall not be refunded (other than as stipulated in the Wait List section above) in the event that a dog is absent, disqualified, excused by vet or judge, or barred from competition by action of the trial committee. Entry fees for bitches that come into season after the closing date will be refunded in full, and injured dogs will be refunded less \$5/class, if notice is given to the trial secretary prior to the start of judging for the day. Injured dog refund requests will require a veterinarian certificate.

**MOVE-UP REGULATIONS:** If a dog earns an agility title before this event it can be advanced to the next level of competition. However, written notice must be given to the Trial Secretary, **no later than 6pm on Monday, December 4** or at the close of the trial each day, which will be considered the availability of ribbon labels for the last class on each day. <u>No verbal changes will be accepted.</u>

**SITE INFORMATION:** The trial ring (74' x 115') is inside on Field Turf. There is NO SMOKING and NO WEAPONS are allowed in the building.

No concessions are available in the facility but entrants are welcome to bring food & beverages. There are fast food places quite close. Workers will receive food & beverages.

Exhibitors and spectators are expected to keep the grounds clean. Please pick up after your dogs. <u>Anyone witnessed not picking up after his/her dog will be excused from the trial weekend with no monies refunded.</u>

**PARKING:** Parking spaces are liimted in front of the building. The back parking lot is available all days and we will attempt to have spots close to the door reserved for people crating in their vehicles. Friday parking is strictly limited to Think Pawsitive spaces - no parking on the north side of the building (down the ramp).

**CRATING:** Crating is available indoors but space is limited. Please keep your setups compact to allow space for all. Social distancing is still strongly recommended. Crate in your vehicle if at all possible to conserve indoor space.

**MEASURING**: All dogs participating in this trial must have an AKC height card or they will need to be measured prior to running in the trial. At least one VMO will be in attendance to measure for official height cards. **Copies of height cards DO NOT need to be sent with entries or shown at the trial!** 

It is the owner's responsibility to have the dog measured prior to running. <u>Awards may be</u> cancelled if the dog is not measured before running.

If your dog needs to be measured, check the entry form box indicating that.

**PRIZES AND AWARDS:** Rosettes will be awarded to the first through fourth place teams in each class and height division. Qualifying ribbons will be awarded to all dogs with qualifying scores. New Title rosettes, Master Double Qualifier ribbons, and Championship rosettes will also be available to teams achieving these accomplishments.

# **Volunteers Needed!**

It takes a village to hold an agility trial! Please consider volunteering to help the trial run smoothly. Volunteers will receive snacks, beverages, and lunch, as well as our sincere appreciation!

AKC rules allow for trials that utilize the Random Draw method to reserve entry spaces for workers. As this is a 1-ring trial, we will be able to reserve 35 handler spaces in the trial. To be considered for a worker spot, please check the "I'm a Worker!" box on the entry form.

The link to the online worker sign-up form will be posted to the creamcitycanines.com website after closing, and will also be included in the the final confirmation emails.

**DOGS ELIGIBLE TO ENTER**: This trial is open to all dogs 15 months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number (for mixed breed dogs), or approved Foundation Stock Service (FSS) breeds, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance.

**HEIGHT DIVISIONS:** Owners are responsible for entering the proper height division. All measurements are at the dog's withers.

**SPECIAL ENTRY INFO**: Exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. In addition dogs may be entered in multiple jump heights within the same day.

For Exhibition Only (FEO) designation of runs will be available in any class.

Fix and Go On (FNG) is available in any class.

**SAFETY/BEHAVIOR:** The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely. Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

**LIABILITY:** It is expressly understood that exhibitors alone are responsible for the behavior of their dogs &/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the show site. In such cases, no refund of any fees paid will be made. Cream City Canines and their agents, employees, etc. will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property, & further assume no responsibility for injury to children.

**OBSTACLES:** Obstacles will meet the specifications for obstacles in the current edition of the regulations for Agility Trials. All contacts and the table are rubberized.

#### INSTRUCTIONS

Handlers may opt to enter in a higher height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs enrolled in the AKC Canine Partners<sup>SM</sup> program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship is the Junior Handler to the Owner?
