Entrants are responsible for the accuracy of their entries. Please review your entry information in the confirmation carefully. If any mistakes are found, please email as soon as possible. Move-ups must be received by **6 pm CST on Monday, December 1** via mail or email.

Site Info: The facility will open for setup at 1pm on Friday and at 6:45am on Saturday and Sunday.

Parking is available in the front of the building and the back lot, but not in the K9 Splash or Employee parking spots. **The closest spots in the parking lots should be left available for vehicle crating. If you are spending all day crated indoors, unload and then move to a spot further out. No parking in the lower parking lot on Friday.** Saturday and Sunday the lower parking lot will be open for our use, and this would be a good option for the place to move your car after unloading if you are crating indoors.

Crating will be allowed indoors BUT it is definitely limited. You MUST keep your crating areas compact to allow space for all. Setups using excessive space will be asked to condense the space used, so save yourself effort and make it compact to begin with - simpler for all of us.

Ground rules: There will be NO SMOKING OR VAPING and NO WEAPONS ALLOWED in the building. Exhibitors and spectators are expected to keep the grounds and building neat and clean. Please pick up after your dogs and dispose of the waste in the receptacles provided. **Anyone witnessed not picking up after his/her dogs will be excused from the trial weekend with no refunds given.**

Check-in: We will be using Agility Gate, an app that allows entrants to check or scratch the dog via smartphone. The class running order is updated in real time so you can keep track of the running order progress without being ringside. A monitor near the ring will also display the order.

The code for the event is 53186. The running orders will be posted to creamcitycanines.com after Monday's moveup date, and Friday's running order will be loaded into Agility Gate sometime Thursday. You will not be able to check your dog in until Friday.

Course maps: Course maps will be posted at the trial and will be available in Agility Gate. Courses will be posted to the app early in the morning before each day's trial. There will be no course copies available for pickup.

Measuring: There will be at least one Volunteer Measuring Official at this trial. **All** dogs without height cards, including those that are in 24" jumping classes, are required to be measured. Failure to measured prior to running may result in cancellation of any qualifying scores or awards! If your dog needs to be measured, be sure to ask well before you are to run, and **bring dog treats.**

Food: Food/beverages will be available for workers. No food can be available for sale but there are several fast food restaurants nearby & you are welcome to bring food in for yourself.

Turn left onto Hwy 164. In 1.2 miles, turn left onto Moreland Rd. In 1.2 miles, turn right onto Pewaukee Rd (Hwy J). In 1.6 miles, the hospital is on the RIGHT.

Directions to trial site:

From the North:

I-41 south to I-94 west (exit 38B). Travel to exit 297, Barker Rd. Keep left at the fork just off the exit. Follow signs to Hwy Y/Barker Rd. Take slight right to Hwy 59/Greenfield Ave. Turn left onto Hwy 164/59. Turn right onto Pearl St then left onto Commerce St.

From the South:

I-94 West (north). Use the two right lanes to take exit 317 I-43/894 toward Madison. Stay to the left for exit 4 onto I-43. Take exit 54 onto Hwy Y. Right onto Racine Ave, then right onto Hwy 164/59. Turn left onto Pearl St then left onto Commerce St.

From the East or West:

Take I-94 to exit 297 - Hwy 18/Moreland Blvd. Use the two left lanes to turn left onto Hwy 164. Turn right onto Pearl St then left onto Commerce St.
